Notice is hereby given that the 2015 Calendar Year Budget of the City of East Orange was approved by the City Council of East Orange, County of Essex on March 23, 2015. A Public Hearing on the Budget was held on April 27, 2015. A Hearing on Budget Amendment #1 was held on Monday, August 17, 2015 at 6:00 PM. A Public Hearing on Budget Amendment #2 will be held on Monday, August 24, 2015, 6:00 PM at which time and place objections to Budget Amendment #2 for the year 2015 may be presented by taxpayers or other interested persons.

BE IT FURTHER RESOLVED that pursuant to N.J.S. A. 40A:4-9 these amendments shall not be effective until after the public hearing thereon.
